Sub: Holding of AIC of TESA

Comrade,

This refers your e-mail dated 25.06.2008 on the above seen in my e-mail after my return from Chennai on 29.06.2008. However, when I was in Chennai I was told by my friends that a letter on the above issue is available in the website of AIBSNLEA, Calcutta Telephone District since 25th June 2008. Also an SMS has been sent by the Circle Secretary, AIBSNLEA, Karnataka Circle to different persons advising them to see the website of AIBSNLEA, CTD and send similar e-mail as yours to GS, TESA(I). I could therefore understand that your e-mail is a part of yet another AIBSNLEA led action program.

2. You have alleged that there was no response from me on your request to hold CWC/AIC of TESA to decide the transfer of Funds and Assets to AIBSNLEA. It is incorrect. When GS, AIBSNLEA wrote me on the issue, it was first duly discussed in the CHQ Office Bearers' meeting of TESA(I) presided over by Com. K. Balasubramanian, President, TESA(I) and a reply was sent to him as per discussion in that meeting. Thereafter, a joint letter originated from the CWC Meet of AIBSNLEA at Bhubaneswar which was sent to President, TESA(I) was received by me from him. This was duly examined and findings were sent to him. I find no reasons to believe that you are unaware of these developments, since all these letters were prominently displayed in the website of AIBSNLEA. However, it is correct that the AIC could not be held so far. But I think that AIBSNLEA cannot complain for that. After all, no other Association had so far held their conference - though this cannot be an excuse for us. I have further made the position clear in my Circular letter dated 30.06.2008 to all concerned regarding the so called 'requisitions' for convening the extra-Ordinary General Body meeting which was received from the GS, AIBSNLEA after its CWC Meet at Bangaluru.

3. I cannot help if you are surprised to find me in Chennai making an arrangement to hold an extra-ordinary General Body meeting or conference whatever it is called. After all, you only requested me to hold it at any convenient location to discuss the need to dissolve the Association. I do not think that Chennai is not a convenient location. Having asked me to hold the same at any convenient location, how far your present backtracking is justified that you can only say. I really wonder what you actually want - at one point of time you will be accusing that I am not holding the Conference and when action is taken to hold the same you will be trying to pull the leg.

4. Further, you have said that “GS, AFSOA has committed before the CWC of AIBSNLEA that they will hold their AIC at the same venue where AIC of TESA will be held”. You have further said that it is absolutely necessary that a venue is suitably decided where AIC of both the Associations can be held. This is a news to me that GS/ AFSOA had expressed his desire to hold their AIC along with the AIC of TESA(I) at the same venue. Because GS/AFSOA never requested GS/TESA(I) to find a common venue. Moreover, the GS/AIBSNLEA in whose CWC, the GS, AFSOA had stated to have expressed his above desire, had not mentioned this either in his letter to GS/TESA(I) or in his Report of the CWC published in Telewave. Further in his letter addressed to GS/AFSOA, which is still available in AIBSNLEA website, the GS/AIBSNLEA has simply asked him to take action to hold his AIC in the background that a `requisition` to hold extra-ordinary GB of TESA(I) has been sent to GS/TESA(I). I think that as Circle Secretary of AIBSNLEA, you need to get the correct position of the issue ascertained from your GS/AIBSNLEA.

5. Your reservation against involving the Circle Secretary, TESA(I), Tamilnadu Circle and its CEC Members etc in the TESA Conference on the plea that they have resigned/deserted AIBSNLEA to join a new Executives' Association i.e. AIBSNLOA has no justification. They might have left AIBSNLEA but not the TESA(I) and we are concerned only about TESA(I). Further, there can not be any comparison between the two comrades, whose names you have unnecessarily dragged in, who long back left TESA(I) to join its rival Association i.e. BSNLEA(I) and the comrades of Tamilnadu Circle of TESA(I) who did not leave TESA(I) at any point of time. They are legally and morally with TESA(I). Further, constitution of TESA(I) does not have any provision to direct its members to join a particular Association. The conventions can only suggest/advice. But this cannot be binding on individuals.

6. I do not deny that I am a `retired person`. But it is from service and not from active life. I think I will remain active as a person for reasonably long years. Anyhow, thanks for reminding me the same. Further you have said that “ Please do not do anything which you have not done so far in your long glorious trade union life”. I do not know what actually is your point for anxiety. But I assure you that in regard to Association, I will fully adhere to the provisions of the Constitution and strictly abide by the Laws on the subject even under undue pressure and unjustified demand. Let us meet in the All India Meet and sort out the issues.
